Employment, office, trade, profession or vocation:

6. You should describe contracts for goods, services or works, of which you are aware, which are not fully discharged, and which are between the authority of which you are a member and:

 - (b) a firm in which you are a partner
 - (c) a company of which you are a director
 - (d) any body you disclosed in question 5.

Land in the area of authority

- 7. You should declare the address of any land in the area of the authority in which you have a beneficial interest (that is, in which you have some proprietary interest for your own benefit). If you live in the authority's area you should include your home under this heading as owner, lessee or tenant.

- 8. You should declare the address of any land where the landlord is the authority and the tenant is a firm in which you are a partner, a company of which you are a director or any body you disclosed in question 5.

Licences to occupy land

- 9. You should declare the address of any land in the authority's area in which you have a licence (alone or jointly with others) to occupy for 28 days or longer.

Interests in companies/other bodies

- 10. You must declare membership of or position of general control or management in any-
 - a) body to which you have been appointed or nominated by the authority as a representative

- b) public authority or body exercising functions of a public nature
- c) company, industrial and provident society, charity or body directed to charitable purposes
- d) body whose principal purposes include the influence of public opinion or policy
- e) trade union or professional association.

Gifts and hospitality

- 11. You must within 28 days of receiving any gifts or hospitality over the value of £25.00 declare the existence and nature of any such gift or hospitality in writing to the monitoring officer.

Other matters

- 12. You must declare any other matter that you believe a member of the public might reasonably regard as likely to influence you.

I recognise that it can be a criminal offence to:

- (1) omit information that should be given in this notice
- (2) provide information that is materially false or misleading
- (3) fail to give further notices in order to
 - bring up to date information given in this notice
 - declare any interest that I acquire after the date of this note and have to declare
